Panama elects Jose Mulino as President

Why in News?

 The Panama's electoral tribunal declared conservative candidate, Jose Raul Mulino as the winner of the country's presidential election on May 5, 2024.

More About the News

- Mulino, a former minister of public security, joins Javier Milei of Argentina (elected in November last year) and Nayib Bukele of El Salvador (elected in June 2019) as yet another rightwing populist elected to power in the region.
- Mulino won 34 per cent of the votes, compared to his nearest rival, Ricardo Lombana, who won 25 per cent. The president-elect has promised to solve the Central American country's array of problems including unemployment, inflation and corruption.

- The Panama Canal, the artificial waterway that cuts across the isthmus and helps connect the Atlantic and Pacific, was built after unsuccessful attempts by the French and finally, a successful one by the Americans.
- From 1914 when it opened till 1979, the United States had sole control over the canal. Today, it is governed by the Panama Canal Authority, which answers to the Panamanian government.

 During the two-day meeting from May 2-3, India and Ghana agreed to operationalize the Unified Payment Interface (UPI) of the National Payments Corporation of India

(NPCI) on Ghana's Interbank Payment and Settlement Systems (GHIPSS) within six months.

- The two countries also explored the possibility of signing Memorandums of Understanding (MoUs) on Digital Transformation Solutions and the local currency settlement system.
- Additionally, discussions were held on leveraging opportunities under the African Continental Free Trade Agreement (AfCFTA). Both nations identified key sectors for collaboration, including digital economy, textiles, renewable energy, and healthcare.
- Cooperation in pharmaceuticals, information and communication technology, agriculture, food processing, power sector, critical minerals, and textiles and garments were also highlighted for enhancing bilateral trade and investment.
- The Indian delegation included officials from the Geological Survey of India, EXIM Bank, and the Indian Pharmacopoeia Commission, reflecting India's diverse interests in Ghana.
- A business delegation led by the Confederation of Indian Industry (CII) accompanied the official delegation, comprising representatives from various sectors such as power, fintech, telecommunications, electrical machinery, and pharmaceuticals.
- Ghana is a key trading partner for India in the African region, with bilateral trade amounting to USD 2.87 billion in 2022-23.
- India is one of the leading investors in Ghana, with investments spanning across sectors such as pharmaceuticals, construction, manufacturing, trade services, agriculture, and tourism.

- Karmayogi Bharat's vision is to transform the Indian civil services capacity-building landscape by establishing a robust digital ecosystem enabling continuous anytimeanywhere learning to make the officials future ready.
- To fulfil the vision, the mission adopted the aim to guide civil service officials in their competency-based capacity building journey by enabling online, face-to-face, and blended learning, facilitating discussions through topical forums, managing career paths, and enabling reliable assessments that credibly signal competencies of officials.
- The meeting appreciated the integration of the e-HRMS platform with iGOT Karmayogi which will enable role-based governance by



- enabling deployment of officers based on their competencies and capabilities.

President of the GST Appellate Tribunal (GSTAT)

 Mishra as the President of the GST
 Appellate Tribunal (GSTAT), in New Delhi.

More About the News

- Justice Mishra's appointment marks the beginning of the operationalisation of the GSTAT, a crucial body for resolving GSTrelated disputes.
- The GSTAT is the Appellate Authority to hear various appeals under the Central Goods and Services Tax Act.
- It consists of a Principal Bench and various State Benches. As per the approval of the GST Council, the Government has notified the Principal Bench, to be located in New Delhi, and 31 States/UTs Benches at various locations across the country.
- The Tribunal will ensure swift, fair, judicious and effective resolution to GST disputes, besides significantly reducing the burder on higher courts.
- The establishment of the GSTAT would

further enhance the effectiveness of the GST system in India and foster a more transparent and efficient tax environment in the country.

The GSTAT's first President, Justice (Retd) Mishra was a former Chief Justice of the Jharkhand High Court and was selected by a Search-cum-Selection Committee headed by the Hon'ble Chief Justice of India.
