- ✓ VSHORADS is a Man Portable Air Defence System (MANPAD) designed and developed indigenously by Research Centre Imarat (RCI) in collaboration with other DRDO laboratories and Indian Industry Partners.
- The missile is propelled by a dual thrust solid motor and meant for neutralizing low altitude aerial threats at short ranges. The design of the missile including launcher has been highly optimized to ensure easy portability.
- The missile and its launcher were designed by the DRDO to be portable, which enables their quick deployment over difficult terrain. It has a range of up to 6-km.
