- The Secretariat of Bihar State Assembly has issued the notification in this regard. Manoj Manzil, a first-time MLA from Agiaon assembly constituency, and 22 others were sentenced to life imprisonment by the designated court on 13th February 2024 in a murder case of 2015.
- The 40-year-old CPI(ML) leader had won the Agiaon assembly seat of Bhojpur district in 2020 assembly elections defeating the JD(U) candidate Prabhu Nath Prasad with a margin of more than 37,000 votes.
