- ☑ The Assam Cabinet has decided to repeal the Assam Muslim Marriage and Registration Act, 1935, taking the first step towards a Uniform Civil Code (UCC) in the state, a fortnight after the Uttarakhand Assembly became the first state in the country to show the green light to the UCC.
- ☑ The Uniform Civil Code (UCC) calls for the formulation of one law for India, which would be applicable to all religious communities in matters such as marriage, divorce, inheritance, adoption.
- ☑ The code comes under Article 44 of the Constitution, which lays down that the state shall endeavour to secure a Uniform Civil Code for the citizens throughout the territory of India.

- ▼ The National Public Health India Conference is a national-level initiative aimed at creating a collaborative learning platform for health professionals to share experiences and best practices. The conference focuses on the insights of health policymakers and implementers, contributing to effective public health program management.
- It highlights innovative approaches in addressing health priorities such as NCDs, Tuberculosis, and infrastructure strengthening, emphasizing collaboration for one health, including aspects of zoonotic diseases, antimicrobial resistance, environment, and climate change.
